



- New Zealand Aluminium Smelter's load during October 2019 was below the contract level of 622MW
- 12-month average switching rate of customers changing retailers but not moving ("trader" switch) was 7.4% at the end of September 2019
- 12-month average switching rate of customers moving and changing retailers ("move-in" switch) was 13.2% at the end of September 2019






NATIONAL HYDRO STORAGE (11 November 2019)

NEW ZEALAND RETAIL


- Meridian's New Zealand customer connection numbers rose 0.8% during October 2019 and have risen 3.1% since June 2019
- Retail sales volumes in October 2019 were 12.6% higher than October 2018
- Compared to October 2018, residential/SMB sales volumes increased by 0.5% (increases in all segments except Agri) and corporate sales volumes increased by 35.9%
- To date this financial year, retail sales volumes are 16.0% higher than the same period last year
- This reflects a 5.0% increase in residential/SMB sales volumes and a 36.8% increase in corporate sales volumes


MERIDIAN'S RETAIL SALES VOLUMES*


NEW ZEALAND STORAGE

- October 2019 monthly inflows were 97% of historical average
- To date this financial year, inflows are 96% of historical average
- Meridian's Waitaki catchment storage moved from 948GWh to 982GWh during October 2019
- Waitaki storage at the end of October
 2019 was 91% of historical average and
 21% higher than the same time last year
- Storage in Meridian's Waiau catchment was above average at the end of October 2019


MERIDIAN'S WAITAKI STORAGE





NEW ZEALAND GENERATION

- Meridian's New Zealand generation in October 2019 was 11.9% higher than the same month last year, reflecting higher hydro generation and wind generation
- To date this financial year, Meridian's New Zealand generation is 5.5% higher than the same period last year, reflecting higher hydro generation and wind generation
- The average price Meridian received for its generation in October 2019 was 57.3% lower than the same month last year
- The average price Meridian paid to supply customers in October 2019 was 57.9% lower than the same month last year
- To date this financial year, the average price Meridian received for its generation is 6.4% lower than the same period last year and the average price paid to supply customers is 10.3% lower



MERIDIAN'S AVERAGE GENERATION PRICE*




- Australian retail electricity sales volumes in October 2019 were 18.7% higher than the same month last year


AUSTRALIAN RETAIL GAS SALES VOLUMES
