June 2021



# June highlights

In the month to 13 July 2021, national hydro storage increased from 70% to 92% of historical average

South Island storage increased to 100% of average and North Island storage increased to 50% of average by 13 July 2021

Meridian's June 2021 monthly total inflows were 159% of historical average

Meridian's Waitaki catchment water storage at the end of June 2021 was 82% of historical average

Water storage in Meridian's Waiau catchment was above average at the end of June 2021

National electricity demand in New Zealand Aluminium June 2021 was 0.5% higher than the same month last vear

June 2021 was the warmest June on record with the nationwide average temperature 2.0°C above average. Rainfall was mixed, including above average rainfall in western Southland

Meridian made calls under the Genesis swaption in June and early July 2021

Outages have been confirmed out to December 2021 on the Roxburgh-Livingstone line as part of the Clutha Upper Waitaki Lines Project

Smelter's average load during June 2021 was **554MW** 

Meridian's New Zealand retail sales volumes in June 2021 were 12.8% higher than June 2020

Compared to June 2020, segment sales increased in residential +2.2%, small medium business +37.5%, and corporate +15.4%. Agricultural volumes were the same as June 2020 and large business volumes were -3.4% lower



### **Q4** highlights

Meridian's Q4 total inflows were 116% of historical average and 40% higher than Q4 last year

Meridian's Waitaki catchment water storage at the end of Q4 was 10% higher than Q4 last year

Compared to Q4 last year, Meridian's New Zealand generation was 12.4% lower at a 180.7% higher average price

By the end of Q4, NZ futures prices had fallen compared to the end of Q3

New Zealand Aluminium Smelter's average load during Q4 was **557MW** compared with **559MW** in Q4 last year National electricity demand in Q4 was 5.6% higher than Q4 last year

At the end of Q4, Meridian's New Zealand customer numbers were 7.0% higher than the same time last year

Compared to Q4 last year, Meridian's NZ retail sales volumes were 23.5% higher at a 7.2% higher average price

All segments showed increased sales in Q4

Compared to Q4 last year, Meridian's Australian wind generation was 2.8% lower at a 28.1% higher average price Hume water storage finished Q4 with 70% more storage than Q4 last year

At the end of Q4, Meridian's Australian electricity customer numbers were 4.3% higher the same time last year




### Market data

- National electricity demand in June 2021 was 0.5% higher than the same month last year
- June 2021 was the warmest June on record with the nationwide average temperature 2.0°C above average. Rainfall was mixed, including above average rainfall in western Southland
- Demand in the last 12 months was 0.7% higher than the preceding 12 months
- New Zealand Aluminium Smelter's average load during June 2021 was 554MW
- 12-month average switching rate of customers changing retailers but not moving ("trader" switch) was 6.6% at the end of May 2021
- 12-month average switching rate of customers moving and changing retailers ("move-in" switch) was 14.2% at the end of May 2021

#### **MARKET ICP SWITCHING (ALL RETAILERS)**



### **OTAHUHU ASX FUTURES SETTLEMENT PRICE**






### **New Zealand retail**


- Meridian's New Zealand customer connection numbers rose 1.1% during June 2021 and have risen 7.0% since June 2020
- Retail sales volumes in June 2021 were 12.8% higher than June 2020
- Compared to June 2020, segment sales increased in residential +2.2%, small medium business +37.5%, and corporate +15.4%. Agricultural volumes were the same as June 2020 and large business volumes were -3.4% lower
- To date this financial year, retail sales volumes are 13.9% higher than the same period last year
- This reflects increased sales in all segments: residential +3.8%, small medium business +23.7%, agricultural +8.7%, large business +12.3% and corporate +18.2%

#### MERIDIAN'S NZ CUSTOMER CONNECTIONS








### **New Zealand storage**


- June 2021 monthly inflows were 159% of historical average
- To date this financial year, inflows are 97% of historical average
- Meridian's Waitaki catchment water storage moved from 1,128GWh to 1,299GWh during June 2021
- Waitaki water storage at the end of June 2021 was 82% of historical average and 10% higher than the same time last year
- Water storage in Meridian's Waiau catchment was above average at the end of June 2021

#### **MERIDIAN'S WAITAKI STORAGE**





### **New Zealand generation**


- Meridian's New Zealand generation in June 2021 was 6.4% lower than the same month last year, reflecting lower hydro and higher wind generation
- To date this financial year, Meridian's New Zealand generation is 10.8% lower than the same period last year, reflecting lower hydro and lower wind generation
- The average price Meridian received for its generation in June 2021 was 95.0% higher than the same month last year
- The average price Meridian paid to supply customers in June 2021 was 89.9% higher than the same month last year
- To date this financial year, the average price Meridian received for its generation is 94.2% higher than the same period last year and the average price paid to supply customers is 94.2% higher






### **Australian retail**


- Powershop Australia electricity customer connection numbers reduced 0.3% during June 2021 and have risen 4.3% since June 2020
- Electricity sales volumes in June 2021 were
   9.1% higher than the same month last year
- To date this financial year, electricity sales volumes are 15.0% higher than the same period last year
- Powershop Australia gas customer connection numbers rose 0.5% during June 2021 and have risen 15.9% since June 2020
- Gas sales volumes in June 2021 were 6.5% higher than the same month last year
- To date this financial year, gas sales volumes are 14.7% higher than the same period last year


### **Australian generation**

- Meridian's Australian generation in June 2021 was 38.6% higher than the same month last year, reflecting higher wind generation and higher hydro generation
- To date this financial year, Meridian's Australian generation is 15.1% higher than the same period last year, reflecting lower wind and higher hydro generation
- Storage at Meridian's Hume hydro power station increased to 64% of capacity by 14 July 2021
- NEM¹ electricity demand in June 2021 was
   2.0% higher than the same month last year
- Spot prices lifted again in June 2021 to be 36% up on the previous month. Active forward prices were also up 14% on the previous month


- Forward LGC sales are marked to market monthly through fair value movements
- Sales settle in February each year
- At which point fair value gains or losses on settled sales transfer to generation revenue
- With the FY21 settlement, generation revenue now includes market to market losses of A\$3M
- This compares with settlement gains of A\$12M in FY20
